() **Season-Long Vendor - Paying for full season** - Fee for the Regular Market Season is \$900 (equals \$30/day). Please note our cancellation policy: If a vendor misses 3 dates (except in the case of illness or family emergency), the vendor forfeits their booth location.

() **Occasional Non-Food Vendor** - Fee is \$40/week and is prepaid weekly through our online payment system. Payments are due by the Tuesday prior to each market. **A deposit of \$120 is required when the application is submitted.** This deposit will be applied to the last three dates of the season. Please note our cancellation policy: 50% of deposit will be refunded in case of season-long cancellation. Deposit will be applied to dates missed during the season that are not due to illness or family emergency. If a vendor misses 3 dates (except in the case of illness or family emergency), the vendor forfeits their booth location.

New in 2019 - If you are signing up for the Tower Grove Farmers' Market Saturday Market, the Tower Grove Farmers' Market Tuesday Market, AND the Boulevard Farmers' Market, AND you are paying your fees in full, you can deduct 10% from your vending fees.

If you choose to pay for the full 2019 Boulevard market season, please enclose a payment of \$900 (which equals \$30 per market) per booth space with your application. Your season-long payment includes the Spring Festival on May 12 (9am-2pm) and the Holiday Market on December 15 (2pm-6pm).

If you choose to pay weekly in 2019, please enclose a deposit of \$120 per booth space with your application. This deposit will be applied to the final three markets of the season. **The weekly vending fee is \$40.**

Cancellation Policy

Cancellations before the beginning of the season will receive a refund of 50% of their deposit. After that start of the season, no refunds will be given.

Deposits will be applied to any date missed during the season that are not due to illness or family emergency.

Late Arrival Policy

Vendors are required to be in their designated market spot no later than 7:15 AM. Vendors who arrive after 7:30 AM will not be allowed to participate in the market that day, no exceptions.

Local Policy

Vendors who wish to sell products not made by their business **must submit a written request to the market** either by email or by letter at the market information booth. Included in the request must be the farm or business that is growing or making the product, a contact name and phone number, and their farming practices and complete list of ingredients if applicable. The sale of any products prior to approval by the market board is prohibited.

Trash Removal Policy

Vendors are required to haul away their trash at the end of the market.
